



City of Tybee Island Adopt-A Program Annual Agreement

This Agreement is made the 1 day of JANUARY 2020,
by and between the City of Tybee Island and

(ADOPTING GROUP), which agree as follows:

Whereas, the City of Tybee Island and ADOPTING GROUP recognize the need and desirability of litter-free streets, parks, marshes, beach crossovers, beaches and other areas on Tybee;

Whereas, the Adopt-A Program has been established for commercial, civic, non-profit organizations and any interested parties to contribute toward the effort of maintaining litter-free streets, parks, marshes, beach crossovers, beaches and other areas on Tybee;

Whereas, ADOPTING GROUP is aware of potential hazards involving work performed adjacent to and near streets, parks, marshes, beach crossovers, beaches and other areas on Tybee, and agrees to promote awareness of such potential hazards to its members and volunteers;

Whereas, ADOPTING GROUP understands that the City of Tybee Island endeavors to support and cooperate with ADOPTING GROUP in the development and implementation of the Adopt-A Program, but neither assumes nor accepts any liability with respect thereto;

Whereas, ADOPTING GROUP understands, and agrees to communicate to its participants and volunteers, that the City of Tybee Island carries no insurance for ADOPTING GROUP or its participants and volunteers engaged in activities related to the Adopt-A Program;

Whereas, ADOPTING GROUP has received copies of the City of Tybee Island *Contractual Obligations / Safety Guidelines* and *Participant Waiver* for ADOPTING GROUP's participants and volunteers; and

I pledge that ADOPTING GROUP does not and will never exclude any person from participation in, deny any person the benefits of, or otherwise discriminate against anyone in connection with the group or its activities on the basis of race, color, or national origin;

Therefore, in consideration of the mutual benefits and interests of the City of Tybee Island and ADOPTING GROUP, the City of Tybee Island recognizes and approves

as the ADOPTING GROUP for:

(STREET/PARK/MARSH/BEACH CROSSOVER/BEACH/OTHER AREA ON TYBEE)

(FROM STARTING / TO ENDING POINT)

Furthermore, ADOPTING GROUP agrees to promote a litter-free environment in our community and accepts responsibility for picking up litter in the above section of street/park/marsh/beach crossover/beach/other area on Tybee at least once per month. ADOPTING GROUP agrees to return a completed Pickup Report following each pickup and understands that not doing so may result in release of street, park, marsh, beach crossover, beach or other area on Tybee to another group.
